

COLONY KEEPS YOU COMPLIANT

NOTICE: Beginning October 14, 2019, general contractors must post worker safety information signs at construction sites where site safety training is required.

The signs must:

- Contain specific information about required worker safety training, including all site safety training deadlines and the number of required training hours, and the information must
- Be in all the languages used by workers to communicate at the construction site. In addition, the signs must
- Be clearly visible to workers and must be posted at the construction site as follows:
 - Sites with construction fencing must post a sign at each egress point on the inside of the construction fencing, including vehicle delivery fence gates and existing loading docks.
 - Sites without construction fencing must post a sign at each egress point within the controlled access zone where construction is taking place and at each existing loading dock or location being used for construction delivery or access.

To comply with the new requirements, the posted sign must:

- Be 44 inches wide and 30 inches high;
- Have letters at least 1 inch (25 mm) high;
- Have white letters on a blue background; and
- Be made of a durable and weatherproof material such as vinyl, plastic, or aluminum that is flame retardant.

ENGLISH - ITEM #43-0111 - ACP

As of December 1, 2019:

- Workers will not be permitted to work on this site unless they have 30 hours of safety training, demonstrated by an OSHA 30 card, a Limited Site Safety Training Card, or a Site Safety Training Card.
- Workers serving as a Site Safety Manager, Site Safety Coordinator, Concrete Safety Manager, Construction Superintendent or a Competent Person, as required by Section 3301.13.12 of the Building Code, will not be permitted to work on this site unless they have 62 hours of safety training, demonstrated by a Supervisor Site Safety Training Card.

As of September 1, 2020:

- Workers will not be permitted to work on this site unless they have 40 hours of safety training, demonstrated by a Site Safety Training Card.

- Los trabajadores que se desempeñen como Gerente de Seguridad en la Obra, Coordinador de Seguridad en la Obra, Gerente de Seguridad de Concreto, Superintendente de Construcción o una persona capacitada, según lo requiere la Sección 3301.13.12 del Código de Construcción, no podrán trabajar en esta obra a menos que cuenten con **62 horas de capacitación en seguridad**, demostradas por una Tarjeta de Capacitación en Seguridad en la Obra del Supervisor.

A partir del 1 de septiembre de 2020:

- No se permitirá que los trabajadores trabajen en esta obra a menos que tengan **40 horas de capacitación en seguridad**, demostradas por una Tarjeta de Capacitación en Seguridad en la Obra.
